- (1) The temporary recognition accorded to the school is valid 23.09.2021 and is to be renewed at an interval of every three years.
- (2) The grant of recognition is available initially for classes LKG- to VIII Std and to be extended for Secondary / Senior Secondary Classes subsequently in due course of time.
- (3) The School shall abide by the provisions of the Right of Children to Free and Compulsory Education Act, 2009 and the Tamil Nadu Right of Children to Free and Compulsory Education Rules, 2011.

 - (b) on the ground of religion, caste or race, place of birth or any of them.
- (8) The School shall ensure that,
 - no child admitted shall be held back in any class or expelled from School till the completion of elementary education in a school;
 - no child shall be subjected to physical punishment or mental harassment. (ii)
 - no child is required to pass any board examination till the completion of (iii) elementary education;
 - every child completing elementary education shall be awarded a certificate (iv) as laid down under rule 21.
 - inclusion of students with disabilities / special needs as per provision of the (V) Act.
 - the teachers are recruited with minimum qualifications as laid under section (vi) 23(1) of the Act: Provided that the teachers who, at the commencement of this Act do not
 - possess minimum qualifications shall acquire such minimum qualifications within a period of 5 years;
 - the teacher performs his duties specified under sub-section (1) of section (vii) 24 of the Act; and
 - the teacher shall not engage himself for private teaching activities.
